STANDING ORDER RE: JURY PAYMENT
OF PER DIEM AND EXPENSES OF THE
GRAND JURY PURSUANT TO
CALIFORNIA PENAL CODE SECTIONS
890 AND 890.1

10 This Standing Order is issued pursuant to the authority of the Supervising Judge of the
11 Grand Jury to ensure timely payment of per diem and mileage expenses to the members of a
12 Siskiyou County Grand Jury as authorized under California Penal Code Sections 890 and 890.1.
13 Penal Code Section 890.1 states:

14 The per diem and mileage of grand jurors where allowed by law shall
15 be paid by the treasurer of the county out of the general fund of the
16 county upon warrants drawn by the county auditor upon the written
17 order of the judge of the superior court of the county.

18 The Siskiyou County Auditor-Controller shall pay per diem and mileage expenses as
19 specified under California Penal Code 890 and Siskiyou County Code Section 2-5.16.

20 Penal Code Section 890 states:

21 Unless a higher fee or rate of mileage is otherwise provided by statute
22 or county or city and county ordinance, the fees for grand jurors are
23 fifteen dollars (\$15) a day for each day's attendance as a grand juror,
24 and the mileage reimbursement applicable to county employees for
25 each mile actually traveled in attending court as a grand juror.

26 Siskiyou County Code Sec. 2-5.16 states:


27 Grand Jurors in the Superior Court shall receive Fifteen and
28 no/100ths (\$15.00) Dollars a day for each day's attendance as a Grand
Juror, upon regularly called jury meetings or committee meetings, or
when appointed by the foreman of the Grand Jury to make individual

1 investigations, plus mileage reimbursement applicable to County
2 employees for each mile actually traveled.

3 A claim shall be submitted to the Auditor Controller upon approval of the Grand Jury
4 Foreperson. Expenditures shall be paid from monies approved and budgeted for operation of the
5 Grand Jury and any request in excess of the amount budgeted for Grand Jury operation shall be
6 submitted to the Siskiyou County Board of Supervisors after approval by the Supervising Judge.
